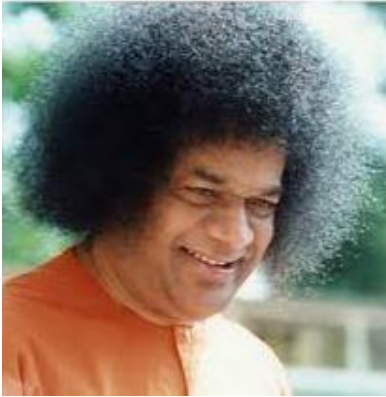

Your deepest innermost urge is to return to yourself—to love yourself, to become Being, Awareness, and Bliss—which is all you will ever be.

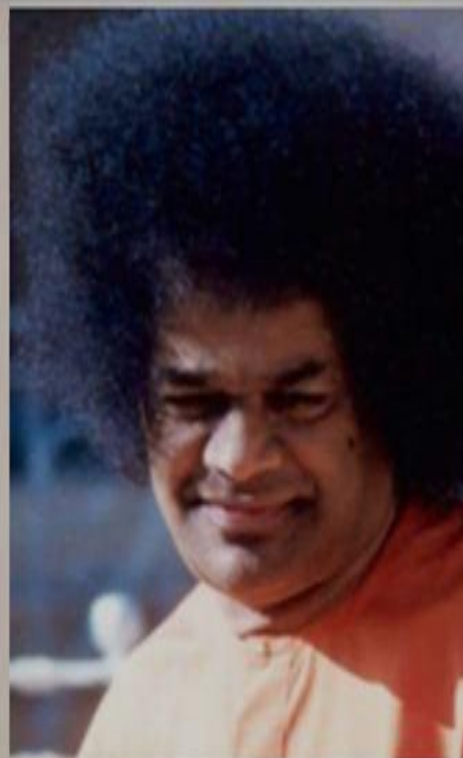
Let go of the past; stop trying to get from each other what you still think you missed in childhood or marriage. You will never find anyone who is enough—not even Me!

Early 1995, Puttaparthi (letter to students)

1. Introduction and brief history

Sri Sathya Sai Gramin Jagriti Sewa Sadan is a multi-dimensional rural based service (*sewa*) project gifted by Bhgwan Sri Sathya Sai Baba to the northern part of rural India with the dual purpose of self evolution of the volunteers (*sewa* workers) through selfless service and empowerment of the beneficiaries through the various services of this project. It bears the name of Bhgwan Baba, because it follows the lofty Sai principle of “selfless service” with “love” as a mode of liberation. The project came into existence with a typical stamp of Swami’s *leela* which is no less than a miracle in itself.

It was in 1990 when Lord Sai blessed one of His outgoing MBA students of Sri Sathya Sai Institute of Higher Learning and inspired him to work in setting up of a multi-dimensional rural empowerment programme. The “*sewa*” work in this project was started on 13th April, 1993. Since then, **Swami** has been guiding, inspiring and protecting us at every step. Important physical milestones in the history of this project are as follow:

Important milestones: *Bhoomi Puja* of the land, gifted by the then Gram Panchayat of village Darwa (Yamuna Nagar, Haryana), was performed on 13th April, 1992. Foundation of the hospital building was laid on 27th September, 1992. The *sewa* work in the project was started in the form of a **dispensary** on 13th April, 1993. Next year in September 1994, *Masala* (spices) production centre was commissioned with a view to provide vocation to economically weaker section of the rural women.

Sri Sathya Sai Jagriti Vidya Mandir was inaugurated on Swami’s 71st Birthday (23rd November, 1996) by a long time Sai devotee -Mr Justice R.Sridharan, the then Chief Justice of Punjab & Haryana High Courts.

The “Parshotam Loomba block” of 6 bigger rooms in a 3-storey format, specially designed for housing meditation room, conference hall, library, science laboratory and a computer laboratory, was completed in 2009.

In February 2009, “Clean water” project, sponsored by Rotary International to meet the supply of safe drinking water to the whole campus, was commissioned.

The major boost to the working of the Project in general and Sri Sathya Sai Vidya Mandir in particular, was received on 19th June 2010 when **Sri Sathya Sai Vidya Vahini** was gifted to school by Bhgwan. This has brought in the cutting edge of latest technology in secular (text book) and value oriented education for the holistic development of the students’ personality.


SOLAR POWER PLANT



An “On Grid” 10KW Solar Power plant has been installed on the roof top of the school for meeting the power demands of the Sadan and reduces the electricity bill. The plant can be remotely monitored on line

SAI BALRAJ GUPTA ASSEMBLY HALL



An  extension of the Hall with a balcony has been added to increase the sitting capacity of the hall

With the grace of the Loving Lord, the multipurpose assembly hall construction is a boon to the infrastructure created in the school. Having LED projector, sound system and auto-curtains control, it serves to host all the school activities such as Baba’s birthday & Annual day celebrations, morning assembly, *bhajan* session and indoor games like badminton, table tennis etc.

“Sai Kitchen” was commissioned in September 2012 to supply freshly prepared, tasty and nourishing vegetable curry everyday to all the students free of cost.

On Baba’s 88th birthday (23rd November, 2013), a multi-purpose assembly hall (**Sai Balraj Gupta Hall**) was inaugurated by Mr Justice K.C Puri, Hon’ble Judge of Punjab & Haryana High Courts, Chandigarh.

With Sai’s loving grace, the School has been affiliated to the National Council of Sri Sathya Sai Schools in 2013. **Thank you Swami!**

In April 2015, the sports ground of the school was developed fully into a stadium for training and organising the games of foot-ball, hockey, Cricket, volley ball and track events. A state of the art, Basket ball court was commissioned in March 2016.

In 2017, the extension of the Balraj Gupta Assembly Hall and addition of a balcony was undertaken to accommodate the ever increasing audience, attending Baba’s birthday and school Annual Day programme.

In February 2018, the school was allotted a **“Girl’s football Nursery”** for 30 students of Yamuna Nagar district by Govt. of Haryana under Golden Jubilee Khel Nursery scheme.

In April 2018, a 10KW “on grid” **solar power plant** has been installed on the roof top of the school. It is now producing electricity.

2. The society

2.1 Membership:

The society was initially registered as “Jagriti” with the Registrar of Societies, U.T-Chandigarh in 1990. With the blessings of Bhgwan Sri Sathya Sai Baba, the name of the society was changed to “Sri Sathya Sai Gramin Jagriti” in 1992. There is **no membership fee**, only contribution of “*Pure Love*” is required for Life time Membership of the society. As on this day, there are 46 members on the rolls of the society. None of the members or their relatives is gainfully employed in the project. The services of the members in various capacities, is purely selfless in nature and no remuneration/perk in any form is ever paid to any of the members. Full list of members/Governing body members is given on pages 61-64(annexure IV). The Deputy Commissioner of Yamuna Nagar and Director Urban Local Bodies Haryana are the permanent nominees of the Govt. of Haryana to the Governing Body of the society.

Funding: The society receives unsolicited donations in its scheduled Bank accounts and no donation box has been kept to receive loose cash donations. The payments of all purchases etc. are made on regular bills. The salaries of the teachers and other staff members are credited to their bank accounts directly. At the end of the financial year, the accounts are audited by a chartered accountant. The balance sheets; receipts & expenditures statements and audit report (please see Annexure V, page 65 onwards) are prepared and presented in the Annual General Body meeting of the society for its approval. An analysis of the data of this balance sheet and comparison with last two years is, however, presented in chapter 9 of this report (page 41-44). Similarly, the Annual Report is prepared and presented in the Annual General Body meeting every year for discussion and adoption.

3. The Project

3.1 Theme of the Project is reset: The theme of the project was initially conceived to be “*Manav Sewa is Madhav Sewa*”. But this theme has since been reset by Bhgwan Sri Sathya Sai Baba on 02-01-2011 during the last interview, received by the management committee members when Swami emphatically told them, “**If you love me, love my words**”.

“LOVE SAI” = “LOVE HIS WORDS”

The *sewa* work in the project is, however, based on the concept of “*Trikarna Shudhi*” i.e., the purity and harmony of Thoughts, Words and Deeds by way of *Sankirtan* and *Sewa* under the guiding philosophy of Bhgwan Sri Sathya Sai Baba.

3.2 Location of the Project: The project centre is situated on the bank of Yamuna canal, 7.5 kms from Yamuna Nagar on old Saharanpur (*Jhhota*) road at village Darwa in Tehsil Jagadhri of Yamuna Nagar district (Haryana). The village Darwa has now been included in Yamuna Nagar Corporation, but the project work continues to serve the rural neighbourhoods.

3.3 The Beneficiaries:

The project has two types of beneficiaries:

Adopted: Three villages are adopted for *sewa* activities:

1. Darwa with population:	1095
2. Darwa Majri with the population:	1162
3. Parwalon with the population:	<u>1693</u>
Total adopted Population:	3950 (Families=520)

In an economical survey of the adopted families, it was observed that 12% families are having good regular income from the farms or regular employment, 36% families are living on income from daily wages or irregular employment and the rest 52% are living “below poverty line”. **All the services rendered by the Sadan are totally free to the population of these three adopted villages.**

Non-adopted: Besides the adopted beneficiaries, unspecified number of patients from the surrounding and far off villages/cities of Haryana, Punjab, Uttar Pradesh, Himachal and Utranchal visit *Sadan* everyday for free consultation. The poorest of the poor amongst the non adopted patients are also provided free medicines and investigations. Students from various non adopted surrounding villages are admitted to the school by a transparent open lottery system, subject to the availability of the seats.

Quality (and not the quantity) is the hall mark of all the activities.

3.4 Components of the Project: There are three wings of the Sadan:

1. Education Wing- Sri Sathya Sai Jagriti Vidya Mandir
2. Health wing
3. Vocational Training & Production centre

These three wings derive their inspiration and energy from the fountain head of energy that is- “The Spiritual Activities”.

The satellite panoramic view of the project site



The circled area depicts the project site. Out of the total area of 7 acres of the land in possession, the School premises are in 4.17 acres (60%), and the remaining 2.83 acres (40%) has the Hospital and residential premises.

On its northern side is the dairy complex, on the southern side; there are farms and Yamuna Canal. The eastern side, the vacant land is reserved for the society to expand its project (Vocational & Skill development is being planned), the village Darwa is situated on the western side of the project.

4. Sri Sathya Sai Jagriti Vidya Mandir -a “Sri Sathya Sai Vidya Vahini”, “Sai School”



Highlights:

- Regular co-educational bilingual school from pre-nursery to 10th class, recognised by Govt. Of Haryana and affiliated to Board of School Education Haryana, providing a high quality, but totally free education to the rural students.
- Special emphasis on “Education in Human Values”-Sai Educare
- The introduction of the newer concept of “Experiential learning”
- Clean, safe and hygienic environment with provision of safe drinking water, separate toilets for boys & girls.
- Qualified & trained teachers with teacher/student ratio as 1:23. Specialist teachers in Science, Sanskrit, Music, Computer Science, Physical training and a Librarian. Regular in-service training for the teachers.
- Six e-class rooms: each having LCD projector, screen, green board and Wi-Fi /LAN internet connectivity for free access to the vast teaching material available on Sri Sathya Sai Vidya Vahini Portal
- Well equipped science and computer labs. Facilities for LCD, slide and overhead projectors. A well stocked School library.
- Well organised school annual calendar for sports, extra-curricular activities and community services. Girl’s Football “Khel” nursery.
- Regular health check-up with 100% free immunisation against Hepatitis B and MMR. Regular Vit D + Calcium supplement for all. Free supply of freshly prepared vegetable curry with rice in lunch from Sai Kitchen.
- Parental involvement (Parenting) in overall personality development of the children by regular Parent-Teacher Meetings.
- Post-schooling career counseling and financial/logistic support including gifting Laptops to meritorious students pursuing higher studies.

With loving grace of Bhgwan Sri Sathya Sai Baba, Sri Sathya Sai Jagriti Vidya Mandir has been declared as a “light House School” after a detailed audit by Sri Sathya Sai Vidya Vahini Foundation.

To explore this fountain head of gifted “knowledge”, the school is adopting the system of Sai Educare. Under this system, an equal and balanced importance is given to both “secular” (board syllabus education) and “EHV” (Education in Human Values). According to Sri Sathya Sai Baba, both of these components of child development are like the two wings of a flying bird, essential for him/her to fly in the mundane world. **Education is for Head, and Educare is for Heart! - Sai Baba**

Sri Sathya Sai Vidya Vahini programme and affiliation to Institute of Sathya Sai Education (Mumbai) are providing the technology and continuing training to the teachers, thus giving impetus of achieving the goal laid down in Sai philosophy of education-“Sai Educare”

With the Institute of Sathya Sai Education (Mumbai) taking over the school under its wings; the new concept of “Experiential Learning*” has been introduced in the school. Sincere efforts are being made to develop the “Character” of the young ones by an integrated approach involving students, teachers and parents through medium of “LOVE”, balanced with “Law”.

Infrastructure: The school management has been able to build a state of the art infrastructure for the children to bloom into a useful individual. There are six e-class rooms of the senior classes, each having a LED projector, internet accessibility, dustless chinks and green boards. The school has an assembly hall, a well equipped Computer lab, a composite science lab, a mathematics lab, a well stocked library and a “Rainbow” room wherein projects models and charts prepared by the students in the past, are stored.

The conference room, the computer lab and the Balraj Gupta Assembly Hall have also been provided with LED projectors. **Sports grounds** for football, hockey, athletics and Volley Ball already exist. **Basket ball court** is an added asset in the school recently. **The school library** has a stock of 3870 books (Reference books 988, Academic: 1500, Story: 560, Spiritual: 700, General Knowledge: 49, Open Board: 34, Novels: 24, and Moral Science: 15). There is a qualified librarian who manages the working of the library.

All class rooms are connected with the Director’s office through PA system. Security CCTV cameras have also been installed recently.

(The Infrastructure)

Connection to the modern world:-

The fully Air conditioned Computer Lab is equipped with 16 computers wherein the students learn how to make the presentations (ppt's), prepare Excel sheet, write in MS Word and also search material for their different subjects. A qualified teacher has been employed to guide & help them. The whole school building is Wi Fi enabled for Broadband internet accesses.



The Library is a garden of silence for the students to enjoy and comprehend and expand their knowledge by reading books of various subjects. The school library is very spacious and well lit. It has a stock of 3870 books and subscribed to sports, science, competition and moral value magazines on regular basis.



The SSSVV e-class rooms:

There are six e-classrooms for 5th to 10th standard, fitted with a LED projector, a foldable screen, a green board. Children are taught the subjects using updated educational videos and lesson plans on regular basis.

The Student

During the academic year of 2018-19, the total strength of the school was 428 students, with 49.8% boys and 50.2% girls. Most of the students (84.3%) were from socio-economically backward classes. Although there is no caste based discrimination of students in the school in any manner yet the detailed break up is given below to meet the information requirement of the Education department under RTE:

The primary classes follow the Haryana Board curriculum in English medium. But, in an effort to bring these rural students at level ground with urban children in competing for admission to professional courses, the medium of instruction for the subjects of Mathematics and Science of 1st to 10th classes has been changed to English. The medium of instruction for the subject of Social Studies is being gradually changed from Hindi to English. Sanskrit is, however, a compulsory subject for all the students.

The school computer laboratory has 16 computers for a class of 35 students. Use of computer technology under the aegis of Sri Sathya Sai Vidya Vahini has not only made the subjects interesting and comprehensive for the students, but it is also inculcating the "moral values" in them. Details of the activities of Sri Sathya Sai Vidya Vahini Programme in Darwa School are given on page 48- 50 (Annexure I)

To encourage healthy competition among the students, **Balraj Gupta Medal** is awarded to the best outgoing student of the school every year. It carries cash award of ` 11000, a merit certificate and a "Medal". Based on well developed protocol of selection with no room for personal bias, Miss Srishti d/o Smt Paramjeet & Shri Ram Pal of Darwa was awarded this coveted prize this year.

The importance of moral education is the basic principle of the Sai Education philosophy. *Bhajan* singing and *Vedas* recitation are the regular features of the morning assembly. Veda chanting training is imparted by Mr Balasubramani Chandrasekhar (National Convener, Veda Chanting for Sai School) who visits the school on weekends once in 6 months.

4.1 Academics

The academic session started with “Hawn” in the premises of the school on 1st of April in which the senior students, teachers and other staff members participated. The academic year (2018-19) had 234 teaching days. The **Teacher /student ratio was healthy at 1:23** with 19 qualified and experienced teachers for 428 students. Emphasis is on regular attendance of the students in the school. The annual average attendance of the school is 96% (Pre-school classes: 94.1% and 96.6% in the school from first to tenth classes).

The Annual Results:

The Annual examination results of 10th class conducted by the Haryana education board are tabulated below for the last 3 years:

*This year. 08 (27.5%) students passed in Merit, scoring more than 75% marks and 13(44.8%) students scored more than 60% marks and rest 06(20.6%) in 2nd Division.

The subject of Mathematics and Science & Technology (average scores of 65.86% and 55.79 % respectively) would need special attention in future.

A special winter free educational 10 days camps for the Xth class was organised with the Grace of Swami, for girls in D.C. Montessori School Mani Majra (U.T.Chandigarh) and for the boys at Govt. Senior Sec. School Jhansa.

Veda Chanting: Baba, who is the Veda Purusha, has educated us time and again on the supreme benefits of chanting Vedas. Every occasion gets started with Vedic chants which leave the whole place charged with divine vibrations. In fact, “Veda Chanting” has become an integral part of His education system. All India in charge of Veda chanting training, Mr Balasubramani Chandrasekar is regularly visiting the school to conduct Veda chanting classes.

4.2 Co-curricular activities:

“Communicative skills and confidence building” have been identified as two areas of concern in the rural education. Regular classes of senior students in General Knowledge and Awareness are conducted on Sundays. In the field of personality development of the children, co-curricular activities play an important role. The school has a regular calendar of such activities.

Twining of School’s/partnership between schools (16th November 2018).

Under the government scheme twinning of school’s /partnership between schools, students from two government primary schools Govt Primary School Darwa and Govt Primary School Bhojpur(30 students) joined their peers in SSSJVM Darwa to observe the activities and other cultural behaviour of the students. The escorts of Govt. schools were wonder struck to see the discipline and performance of the children of SSSJVM. In the end of the programme, the refreshment was served to the participants and the teachers.

Detailed reports of the annual features of historical & cultural events and festivals round the year have been included under “Ancillary Activities” (Annexure II on page 51-59).

4.3 Annual Sports Day of the School on 3rd November 2018

21st Annual Sports day of the school was celebrated on 3rd November 2018 with the great enthusiasm and well preparations. The S.D.O. of Yamuna Nagar Sh. Rajinder Gupta Ji was the Chief Guest. After the March past, dumbbell exercises and a brief cultural programme the prizes of various Sports events at District level were given to the winners by the Chief Guest.

He spoke very high about Sri Sathya Sai School and appreciated all the students for their well-disciplined manners. He assured that he would always be helpful to the institution regarding organization of Sports activity. After that he declared the meet open. Final matches of Kho-Kho, Kabaddi and volley ball were played. Children showed great interest in athletics (100 mt, 200 mt, 400 mt. races).

The outstanding achievement of the year was running of a Football Nursery for the Girls .Under this scheme of Govt. of Haryana, a batch of 30 girls were selected from Yamuna Nagar district for training in the game of Football. Each girl gets Rs 1500 per month as diet money, a qualified coach and development of grounds and equipments.

It is from this nursery that a 9th class girl, Komal was selected to represent state of Haryana at All India Junior girl's football championship held at Kohlapur. Her team lost to Himachal Pardesh team in semi final and was declared joint 3rd in this championship.



“HEALTHY MIND IN A HEALTHY BODY”



The school provides infrastructure for developing sporting talent of the children. The basket ball court and an accomplished coach have proved to be boons to the students to learn this beautiful game of physical endurance and skill. A huge ground for the games of cricket, football, hockey and athletics is available for the children.



The Haryana sports department has allotted “Sports Nursery” for training 30 Girls football players through this nursery. A qualified coach and Rs 1500 per month per child are provided by the govt under this scheme

THE ACHIEVERS IN SPORTS FIELD

Basket ball teams, Boys and Girls, participated in State level Basket ball tournament held at Hisar and won the certificate of appreciation and participation.



The Football nursery has nurtured the students to raise two teams. The U-17 team represented the Dist Yamuna Nagar at state level tournament held at Mohindergarh from 23rd to 25th November.

The U-14 team also scored first position at the district level and represented the district at State level tournaments held at Panipat from 3rd to 5th October

4.4 School Health Programme:

The health of each student is monitored by maintaining his/her health card. Besides regular medical/dental check up and deworming of the school children twice in a year, all new admissions were immunised against Hepatitis B and MMR (Measles, Mumps and Rubella), thus achieving 100% immunisation in the school. The anaemic children were given oral iron on regular basis. Every student received Vitamin D and Calcium supplement on 90 days in the calendar year. The results of these health providing programmes are encouraging in terms of gain in height, alertness and mental ability of the students.

“Sai Kitchen” was commissioned in September 2012 for supplying freshly prepared, tasty and nourishing vegetable curry to all the students free of cost. A new initiative has been taken wherein rice with vegetable was provided to all the children every day.

4.5 Extending help:

- Child adoption scheme : Any student who has either lost his/her father or whose mother has been deserted by her husband, was adopted under the “child adoption scheme” for the purpose of providing free books, uniform/shoes and board examination fees. This year, ten (10) such students had been adopted. Donors from U.K are adopting these children on regular basis.
- Providing books, shoes and vision correcting glasses on regular basis to all those students who cannot afford.
- Laptop computers: Till now free 7 (seven) laptop computers have been gifted to deserving ex-students pursuing professional courses (details on page 61)
- Career counselling: Data base of all the ex-students has been generated to keep a track of the progress made by alumni in their career. Regular meetings with these students were held. Such meetings provided the opportunity to counsel them on their problems encountered by them while pursuing higher studies and also to guide them for their future career. Logistic support is also given to these students in “online” filing of applications, seeking of results and guiding in admission process to various professional courses.
- Financial support was given to economically poor students to pursue their higher studies. Priyanka and Monika are receiving financial support for B.Sc (Nursing), Miss Srishti is receiving financial support for her 10+2 course in Sri Sathya Sai Vidya Vihar Kalkaji extension, New Delhi. Three students are being provided free education (no tuition fees and free accommodation) in D C Montessori School UT Chandigarh. Details are given in Annexure III (B) on page 60.

SCHOOL HEALTH PROGRAMME



“Sai Kitchen” was commissioned in September 2012 to provide freshly prepared nutritious and tasty vegetable rice curry, prepared under the most hygienic conditions, to all the students during their Tiffin time free of cost.

The impact of this activity, inspired by Sri Sathya Sai Baba, is positive on the health of the children. They are eating well with the availability of fresh and tasty vegetable curry with rice.



The other health caring programmes for the school include regular biannual medical/dental check up, 100% immunization of all the students against Hepatitis B and MMR (Measles, Mumps and Rubella). The anaemic children are given oral iron on regular basis. The teachers are also covered for immunization against Hepatitis B and Iron + Calcium

The Teacher

4.6 Teacher's training and their other activities :

There has been emphasis to impart in-service training to school teachers under the philosophy of Sai Educare. The teachers are sent for various workshops/conferences conducted by Sri Sathya Sai Vidya Vahini at Puttaparty and Institute of Sri Sathya Sai Education in Mumbai on regular basis.

The details of the activities under Sri Sathya Sai Vidya Vahini programme and Institute of Sathya Sai Education(Mumbai) are given on page 48-50 (Annexure-I). The other teacher's related activities are, however, highlighted below:

TEACHERS' DAY CELEBRATION (5th Sep. 2018):

Teachers' day was celebrated on 5th September 2018. The students of X class became pupil teachers to understand the nobility of this profession and also to know the difficulties and the challenges the teachers face. During morning assembly, Dr. Sarvapalli Radha Krishnan's picture was garlanded by the Director and the headmistress of the school. The students performed group songs and lovely poems to show their respect for the teachers. Video clippings were also shown to them. The teaching in different classes by the students of X class was a great experience for them. They shared their experiences and expressed their gratitude for the teachers. Refreshment was also served to them.

Bhgwan Sri Sathya Sai Baba was gracious enough to arrange lovely gifts of sarees and safari suits for His teachers as HIS birthday gift in advance. Smt. Urmila Gupta distributed the gifts to the teachers and showered her love & blessings upon everyone. Delicious refreshment was also arranged by the management.

"Bridge course" for the teachers

In pursuance to Government policy, eight teachers of our school who are already B.Ed. and are teaching primary classes, undergone the "Bridge Course" to add more innovative ideas and activities into the teaching- learning process. This course was mandatory for the teachers teaching primary and secondary classes.

All these teachers passed their bridge course examination in flying colours.

“No More Boring Walls “



Under this project, children have been encouraged to paint the pictures on the walls showing IIEP (Insightful, Inspiring, Enjoyable, and Participative) principles. This activity brings out their creativity and devotional attitudes towards work. Above pictures have been taken from the corridors, staircase area, boundary walls and entry gate passage of the school.

As mentioned in the beginning, the third factor in the child personality development is the importance of the role of Parents. The school, not being a residential one, is heavily dependent on the home environment of the students for their proper upbringing. But, the home environment in rural India exposes the children to all sorts of social evils like drinking, gambling, use of abusive language, quarrelling with neighbours, loud music etc. Hence, there lies a challenge for the teachers to counter these evil forces surrounding the delicate and sensitive minds of the children. The parents are informed about the various activities/ meetings/special instructions /school closures etc through bulk SMS service in Hindi.

4.7 Parent-teacher meetings: “Poor parenting” by parents at home is the cause of concern for the school administration. The usual story is that the parents have no control over their children because of their habits spoiled by parents and grandparents.

A parenting programme was conducted by the Director of the school on 6th October 2018 in the school hall. After Aumkaram ,the school Headmistress Mrs. Madhu Sharma welcomed all the parents.

The Director of the school highlighted some important points and guided the parents on the following points:

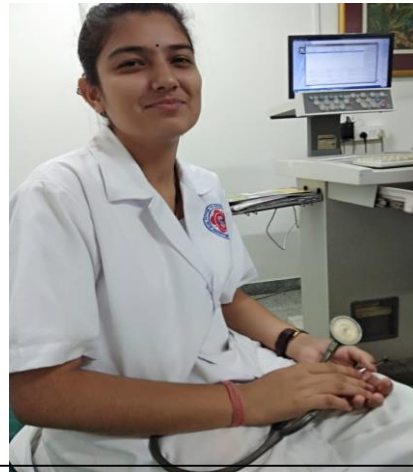
1. The parent’s cooperation is most important to run the school smoothly.
2. She cleared the parents that there is no special evaluation system in place for the Pre-school classes. The children are observed regularly regarding their memorization, speech part, attentive listening and understanding. Monthly grades are provided to them.
3. The children should be taught regularly by their parents to show great concern and respect towards their elders and develop the habit of listening carefully.
4. In the morning, parents should leave their wards at the school gate and must not try to enter in the school campus. Children should develop the habit of keeping their surroundings clean. They should not pluck the flowers or leaves etc. Many times they have been seen uprooting the small plants.

In the end, Madam advised the parents to encourage and motivate their children to keep their belongings in order and resist the temptation of eating any kind of food from vendors and Rehriwalas. The meeting ended with Shanti Path.

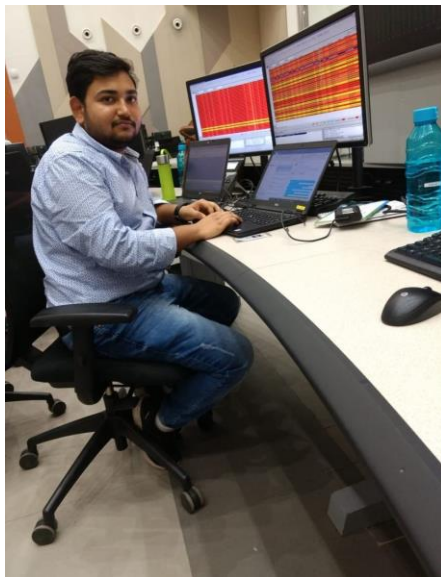

HEALTH WINGHighlights:

- Regular OPD for 6 hrs daily from Monday to Friday and 3 hrs on Saturday, manned by 2 qualified and experienced doctors.
- 300 mA X-Ray machine, ECG machine and Laboratory facilities for routine laboratory investigations and full range of Physiotherapy equipments, manned by locally trained personnel.
- Regular Specialist clinics, once in fortnight for Internal Medicine and Dental patients run by qualified doctors. Homeopathy clinic, once a week. Daily Orthopedics and Gyne. Obst clinics.
- School Health Programme
- A “24X7” Ambulance service for the adopted population.

5.1 The beneficiaries:

Two types of beneficiaries are attending the Out Patient Department for seeking free medical consultation. Their beneficiary status and entitlement are tabulated below:

The hospital building houses the outdoor medical examination facilities with provision for X-Rays, laboratory and dispensary. Six beds are available for observation of the patients.

Specialists’ clinics: A state of the art Dental Chair has been installed to provide treatment to the dental patients. Besides the dental clinic, special clinics for “Internal Medicine” and Homeopathy are also run in the evenings. Prior appointments are given to the patients for these clinics. Orthopaedics and Gyne. - Obst consultations are available on daily basis in the morning times. Emergency services are provided round the clock for adopted patients only. The serious patients are transported to hospitals/nursing homes in the nearby twin cities of Jagadhari/ Yamunanagar.

HEALTH UNIT



Sadan has a humble “health Wing”, mainly the OPD dealing all patients with love and compassion. The wing has earned a name for fair dealing and positive approach. Patients come for free consultation from far off places of UP, Utranchal, Haryana & Panjab. Popularly known as “Sai Baba” hospital, a large number of orthopedic patients come for balanced opinion and treatment. Besides the free consultation, the unit has a clinical laboratory manned by a senior lab technician, a 300 mA X-Ray Machine and state of the art Dental chair. There are six observation beds, but the patients requiring Indoor treatment are taken to Nursing Homes in Jagadhari /Yamuna Nagar. Ambulance service is available round the clock for this purpose. For the convenience of patients coming from far off places, telephone booking of token has been introduced

Looking at the difficulties faced by the patients coming from far off places to avail the token system, a new successful system of token telephone booking has been introduced through a dedicated contact number.

5.2 Out Patient work:

The Outpatient starts at 8 am in the summers and 8.30 am in the winters with *Aunkaram* and singing of *Bhajans* in “*Stuti*” of Lord *Ganesha* and *Guru Baba*, followed by “*Sarva Dharma Prarathana*”. The *Vibhuti Parsadam* is then distributed and the patients are made to sit comfortably, men and women separately. The patients are seen on first-come-first-serve basis using a digital token display system. The adopted patients, toddlers and senior citizens (>65 yrs of age) are given priority.

Considering that there were 301 working OPD days during 2018-19, the average number of patients attending the OPD per day was 72 with percentage of adopted patients as 59.1% of the total OPD registration.

5.3 Anti-tubercular treatment:

Since the beginning in April 1993, a total of 151 patients (average: 06 per year) of tuberculosis (Pulmonary and extra Pulmonary) have been diagnosed in adopted population of Darwa village. The breakup of these cases is as follows:

*Healed and rehabilitated: 135 *Recurrence: 04 (Treated subsequently)

*Died due to the problem: 06 *Treatment discontinued by pts.: 06

While the incidence of Tuberculosis is on the rise in all our India, the incidence in village Darwa has been on the decline. Thanks to persistence efforts to persuade the villagers to follow the standard hygienic habits and give up smoking.

HEALTH UNIT - OTHER SERVICES



A dental chair has been installed for the dental surgeon to take up routine procedures in the OPD only

The Health Unit has full set of routine Physiotherapy equipments like automatic traction machine, SWD, Ultrasonic therapy, Wax bath, shoulder wheel etc.



The health unit has 4 observation beds for care of the patients requiring short observations.



The ambulance service is available 24X7 for the adopted patients for shifting the patients to designated nursing homes in Jagdhari and Yamuna Nagar



5.4 Laboratory, ECG and X-Rays facilities:

A semi- automatic analyser has been installed in the OPD, manned by a qualified Laboratory Technician to prepare hematology, bio-chemical and Urine analysis investigation reports. Samples for more sophisticated tests are sent to advance Laboratories at Chandigarh/Delhi. An ECG machine is also now available in the Outpatient. Sadan has purchased a new 300mA X-Ray machine powered by a 25KVA generator, for carrying out routine radio-graphic investigations. As per legal obligation, the X-ray facility in the Sadan Hospital and the X-Ray technician are registered with Atomic Energy Regulation Board of Govt. of India for monitoring the X-Rays exposure to the technician.

5.5 Some facts about rural Health services:

- a) Common ailments: Contrary to the common belief, the rural women are found to be commonly suffering from Hysterical neurosis. Worst of all, the family members don't understand it and get exploited by unscrupulous nursing homes. Second common problem is Epilepsy due to Neuro-cystecercosis.
- b) The problem of alcoholism is taking a toll on the socio-economical milieu of poverty and undernourishment of family members, domestic violence etc. Death in young age due to chronic alcoholism is common. Illegal sale of liquor in the village is continuing in spite of several representations submitted to the authorities.
- c) The quacks ("doctors") are playing havoc with the psyche of the villagers. These "doctors" also work as touts for the nursing homes flourishing on illegal medical malpractice, resulting in unwarranted costly investigations and unwarranted operations such as appendectomies and hysterectomies etc.

5.6 The School Health Services: Kindly see health under "Education".

Calcium + Vi D tablets are given to all the children of the school on regular basis. In all, a total of 22500 tablets (from class IST to Xth) + unspecified sachets of Vit D granules (for pre-school classes) were given during the year.

5.7 Indoor Patients:

As per policy, the patients from adopted villages requiring indoor treatment are admitted to various Hospital/Nursing Homes at Jagadhari/Yamuna Nagar for different problems. Besides, the financial help, these patients are given logistic support in the form of personal visits, arrangement of blood, food and transport. Financial help was given to deserving patients for their sophisticated costly laboratory investigations. A brief summary of these patients is given in Annexure-III (page60-61).

5.8 Births and Deaths:

A regular record of births and deaths in village Darwa is kept meticulously (tabulated). The data of births has been useful for keeping the immunization record of all the newly born and also for admission to nursery class of Sri Sathya Sai Jagriti Vidya Mandir.

5.9 Feed Back Mechanism:

A team of doctor and volunteers visit the village every Tuesday and some of the Saturdays for interacting with the beneficiaries with the purpose of getting “feed-back” from them and for their counselling in the matter of health and the education of their children. This gives them the opportunity to update the family data in the Sadan records. The inputs from these visits help in making adjustments in delivery system of the various service activities.

6. Vocational Training & Production Centre

6.1 Masala production Centre:

Masala (spices) production centre was established in September 1994 with the following aims in mind:

1. To provide vocation to the rural women so that their economy is improved. Three women and a village boy have been employed in the *Masala* Centre.
2. To educate these working women in basic hygiene so as to improve their health.
3. To provide pure high quality *masalas* (spices) to the society.

Strict control on quality is maintained at the point of purchasing of the raw materials and production. Each packing has a label, indicating the name of the *masala*, its date of manufacture, weight when packed and its cost. In case of any complaint, the material is replaced without asking any question.

The sale is promoted by the members in their social circles, both at Yamuna Nagar and Chandigarh. A sale counter has also been kept in the hospital section which attracts many visitors.

This year, the average monthly salary of ` 1936 has been disbursed to the rural women for their labour. This amounts to an average labour rate of ` 44.67/hr. A comparative data of *Masala* Centre progress over the last 3 yrs has been tabulated as follows:

Masala (spices) production centre was established in September 1994 with the following aims in mind: 1. To provide vocation to the rural women so that their economy is improved. 2. To educate these working women in basic hygiene so as to improve their health. 3. To provide pure high quality "hand ground" *masalas*



The raw materials of the masalas (spices) are procured from the market, cleaned, grounded and packed hygienically. There is a quality control at each step of the production. A solar drier is used to dry the raw material.

6.2 Employment opportunity: The various wings of the project are providing job opportunities to the adopted population. In the non-technical areas, the jobs are offered to economically weaker families of the adopted population, irrespective of caste or creed. But for the technical jobs, the applicants from the adopted villages are required to compete with others in a merit based open/transparent selection process.

Besides the two doctors working on voluntary basis, there are 48 regular jobs available in the project. Out of these total 48 jobs, 21 are occupied by the adopted villagers. One village woman has been engaged to run the *Sadan* canteen.

All the employees are covered under ESIC and EPF schemes

The gains are wonderful. The darkness of "ego" of the volunteers is gradually being removed by the effulgence of sprouting "Love" in their hearts. One does hear now and then, the comments on feelings of better control of emotions, hatred and jealousy towards others.

We pray to Bhgwan Sri Sathya Sai Baba to restore the old enthusiasm in the hearts of our worthy members so that they participate in these programmes more vigorously to enjoy the bliss of taking a dip in the Ganges - the ocean of love, flowing at our doorsteps.

8. FUTURE PLANNING

Bhgwan Sri Sathya Sai Baba had told a group of society members in an Interview that the evolution of this project will be directly proportionate to the individual evolution of the workers working in His mission.

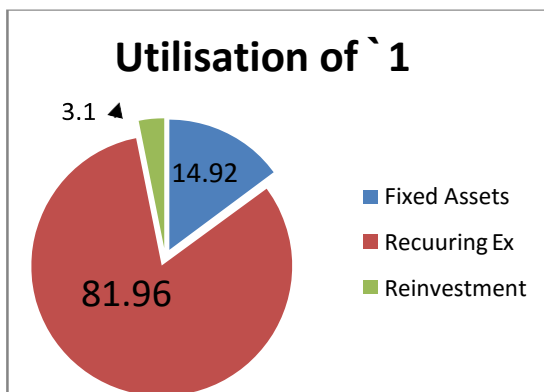

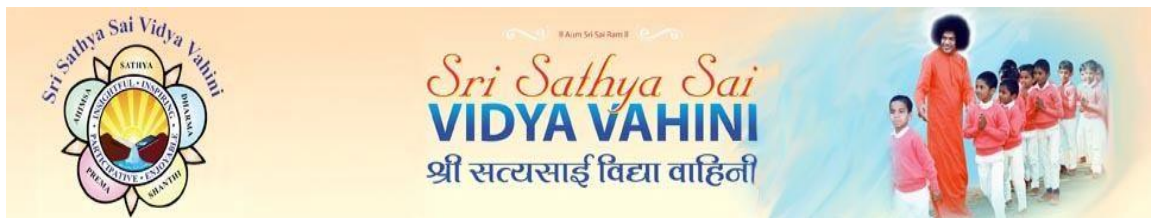
